New Information

Effective January 1, 2025, legislation allows for the issuance of a Salvage Certificate or Nonrepairable Vehicle Certificate to Salvage Pools. The Department of Motor Vehicles (DMV) allows Occupational Licensees, authorized by an insurance company, to take possession of a vehicle that is a total loss claim and is later abandoned by the owner on the Salvage Pool or Occupational Licensee's premises.

Procedures

Requests for a Salvage Certificate or Nonrepairable Vehicle Certificate for abandoned **total loss** insurance claim vehicles **must** be made by the Salvage Pool or Occupational Licensee on the Abandoned Vehicle Application for Salvage Certificate or Nonrepairable Vehicle Certificate (REG 479, NEW 2/2025) form.

- This process is only for **total loss** insurance claim vehicles, where the insurance company authorizes a salvage pool or occupational licensee to take possession of the vehicle.
- The entity that authorized the Salvage Pool or Occupational Licensee to take possession of the vehicle must be an insurance company.
- Possession of the vehicle **must** be taken, and the vehicle **must** be currently located in California.
- The applicant's Occupational License Number **must** be on the REG 479.
- The Salvage Certificate or Nonrepairable Vehicle Certificate shall be issued only in the Salvage Pool or Occupational Licensee's name.
- Copies of the notices sent to the parties are **not** required to be submitted with REG 479.
- Section 3 of the form allows for up to four separate entries. If five or more entries are needed, the applicant **must** attach additional page ones of the REG 479.
- A separate Application for Salvage Certificate or Nonrepairable Vehicle Certificate (REG 488C) form is **not** required.
- On all DMV forms, including REG 479, the signature for a company/business **must** include the printed name of the company/business and an authorized representative's countersignature on the signature line (for example, ABC CO. by John Smith, agent, **or** John Smith, agent for ABC CO.).

Background

Recent legislation allows for the issuance of a Salvage Certificate or Nonrepairable Vehicle Certificate to Salvage Pools and DMV Occupational Licensees for abandoned vehicles meeting *Vehicle Code* §11515.3.
